**GUIDELINES ON THE LAKE**

The Lake is an exclusive resort property. Please respect fellow participants, visitors, customers and residents of the Lake. We must keep in mind that we are visitors and must honor their property policies and rules. These include keeping debris and noise to a respectable minimum and following these guidelines:

1. The Lake and LVHCC waivers must be signed before a person is allowed to paddle. Parent/legal guardian must sign for minors (under 18 years old) and must accompany minors during practice.
2. NO SWIMMING at the practice site. However, all paddlers must know how to swim and attend the LVHCC Safety Session.
3. Please come dressed appropriately for practice and weather conditions. There are no public fountains so bring drinking water. Bring a towel in case you get wet. There are no marina locker/shower facilities. So keep your valuables at home or in the car.
4. Only scheduled paddlers are allowed at the practice site on scheduled practice days. All paddlers must sign-in at each practice.
5. The dock is used primarily by the resort's paying customers and can get crowded. Therefore, during practices, only paddlers **ready to board the canoe** are allowed on the dock. Parents and guests of paddlers must watch from shore and remain off the dock area.
6. Limited amount of paddles are provided. It's best to bring yours.
7. Access to the outrigger canoe must be arranged/scheduled by the LVHCC. No OC-1 or kayaking allowed for LVHCC participants.
8. Any canoe/equipment damages must be reported to the coach.
9. The following are **NOT ALLOWED** on the practice site: possession of or drinking of alcohol or use of illegal drugs; fighting or disruptive behavior; tents, barbecues or other unauthorized/unscheduled activities that may disrupt the normal activities or hinder paying customers of the resort/marina.

*With these guidelines in mind, we can participate and practice in a sport that we all love in a setting that is convenient and safe.*
